Terms and Conditions for winning bidder

- 1. The submission of bid is 28th September 2020 on or before 2.30 PM and the same shall open at 3.00 PM at Dzongrab Office.
- 2. A bidder should submit two documents (ONE ORIGINAL & OTHER COPY) inside the big outer envelope addressed to Dzongdag, Samtse Dzongkhag.
- 3. The proprietor shall be required to submit a lump sum amount of **Nu. 30,000.00** (**Ngultrum: Thirty Thousand**) only as a bid security deposit to the Dzongkhag in the form of cash warrant, demand draft or unconditional Bank Guarantee issued by recognised financial institutions of the kingdom of Bhutan at the time of submission of bid. The bid validity should be 30 days minimum from the date of bid opening.
- 4. This tender is on framework contract basis and will not exceed one year. Therefore, the contract duration shall end on 30th September 2021.
- 5. The quoted price for the food menu shall include all taxes, service charges and any other costs involved till the end of contract period and nothing extra shall be paid. The separate service charge shall not be eligible.

- 6. The evaluation for catering service is LOT WISE and not ITEM WISE. Therefore, there shall be only one winning bidder which shall be the lowest evaluated bid. A bidder shall be evaluated considering the rate quoted mentioned in the price schedule table besides other requirements.
- 7. The catering shall depute enough man power to do catering services. There should be at least 2 staff to carry out catering services.
- 8. The rate should be sold as per the approved quoted menu rates. If it found charging beyond the approved rates, the catering will be given final warning in writing. Repeating the same shall lead to termination of the contract and forfeiture of performance security.
- 9. A sum of **Nu.30,000.00** (**Ngultrum; Thirty thousand**) only shall be required to furnish as performance security by the winning bidder. The performance security should be valid till 30th September 2021. The bid security of unsuccessful bidder shall be returned after signing the contract agreement (attached) with the winning bidder.
- 10. A fresh and hygienic food items should be served from time to time and enough as per the demand/order of the Dzongkhag.
- 11. The owner should strictly adhere to the punctuality, promptness in services and proper dress code of the staff members while delivering the service.
- 12. The staff should strictly follow the health protocols for all times to come.
- 13. The Dzongkhag shall not be responsible for providing kitchenware items such as crockery cutlery, and other items for rendering catering service.
- 14. Samtse Dzongkhag has pledged to substitute single use plastic plates, cups and spoons with **bio-plates** as an alternative towards reducing plastics. Therefore, catering service shall ensure that no plastic plates, cups and spoons are used for rendering catering services to Dzongkhag.
- 15. The decision of the tender committee shall be final and binding.
